FCHS will provide the client with a voucher for up to \$175, with a \$25.00 co-pay due when you apply. Please be aware the voucher can only be used for well care office visit, vaccines and/or tests. After 30 days an extension is available by contacting FCHS, after the 30 days grant funds may be given to another person, refunds will be on a case by case basis.
